TECHNICAL SUBCOMMITTEE T1P1 WIRELESS/MOBILE SERVICES AND SYSTEMS July 20, 2001 Ottawa, Canada

1 Call to Order/Quorum Call/Opening Remarks

Mark Younge (VoiceStream), Vice Chair of T1P1, called the meeting to order at 8:02 a.m. He explained that Chairman Asok Chatterjee (Ericsson) was unable to attend this meeting due to complications from a detached retina.

Quorum Call

Following introductions, roll call was conducted by the T1 Associate, Nicole Butler (ATIS), to establish voting members in attendance. Without objection, the membership approved multiple votes held by Dick Bobilin (Acterna), for Alcatel, CSI Telecommunications, Harris Corporation, Paradyne, and Rythms, and by Quent Cassen (Conexant), for Ericsson. Designated representatives were Sonia Garapaty (for Nortel Networks), Wing Yeung (for Qualcomm Incorporated), Bob Hall (for SBC), and Ed Ehrlich (for Golden Bridge Technologies). T1P1 voting membership stands at 43, requiring 14 members present for quorum. 20 voting members were recognized and quorum was met. Letters are on file for all designated representatives. The membership roll call response is available as an attachment to these minutes.

2 Approval of Agenda and IPR Statement

The updated meeting agenda, T1P1/2001-070R1, was approved without modification.

Patent Disclosure

The Vice Chair stated T1's policy with respect to patents as follows:

Other than reaffirming their company's previously stated position, does anyone wish to make any statement regarding IPR on standards being worked in this committee?

There was no response.

3 Approval of Previous Meeting Minutes

The minutes of the April 27, 2001, T1P1 meeting, T1P1/2001-071, held in Keystone, Colorado, were approved without modification.

4 T1AG/T1 Actions Relating to T1P1

• Vice Chair Mark Younge reported that budget issues were the top concern in the T1/T1AG June 2001 meeting. He referred to measures Committee T1 is adopting to help ease the budget concerns, including the cost cutting measures taking place in meeting planning and a special assessment of \$1000 to voting members of Committee T1.

5 <u>T1P1 Surveillance Ad Hoc Report</u>

Ron Ryan (Nortel Networks), Chair of the T1P1 Surveillance Ad Hoc (T1P1.SAH), presented the report from the Surveillance Ad Hoc meeting on Monday, July 16, 2001 (T1P1/2001-095) via speakerphone. Mr. Ryan requested approval of the following recommendations:

These T1P1 Meeting Minutes are draft and subject to change and approval at the next T1P1 meeting. Any such changes will be reflected in the "Approval of the Meeting Minutes" section of the subsequent T1P1 Meeting Minutes.

- Continue the process of contributing U.S. requirements into 3GPP 33.108 and adopt the working document in T1P1/2001-087 as a basis for specifying U.S. specific requirements as necessary. If 33.108 fully meets U.S. requirements and there are no U.S. specific requirements, the working document can be discarded.
- Request a meeting in early August (August 10, 2001) and another meeting in September 2001 to
 progress work on GPRS and UMTS Lawful Intercept (LI) standards. The results of these T1P1.SAH
 meetings would be used to contribute, as necessary, to 33.108 for the 3GPP SA3-LI meetings in
 August and October 2001.
- Continue to participate in the proposed TR45 Lawfully Authorized Electronic Surveillance (LAES) activity and provide input to a J-STD-025 revision on packet data, as necessary.
- Send a liaison/correspondence to Ray Hapeman in regards to T1P1/2000-093 detailing T1P1's plan for addressing LI standards for GPRS and UMTS. This liaison can be found in T1P1/2001-094.
- T1P1 will retain the scope and work item for GPRS and UMTS LI standards, including the HI2 and HI3 Handover interfaces, as they apply to the U.S./CALEA.
- Request a 1/2 day session for T1P1.SAH in October 2001 on Thursday afternoon during the full meeting of T1P1.

These recommendations were approved by T1P1 with the following concerns noted by Bob Hall (SBC):

Regarding the recommendation to provide input into J-STD-025, as necessary, T1P1 needs to ensure that concern for safe harbor is addressed in T1P1. Safe harbor currently exists under J–STD-025 and T1P1 should align with this and be careful about being outside this safe harbor. Safe harbor is not the choice of T1P1 but is determined by the FCC and the courts.

Regarding the recommendation to retain the scope and work item for GPRS and UMTS LI standards, references to GPRS data and its addition to this work are fine but implications of the word "packet" to go beyond this area to alter the packet technologies may cause problems as indicated in the packet data JEM. This area is yet to be determined.

6 T1P1.2 GSM/3G Radio Working Group Report

Don Zelmer (Cingular), Chair of T1P1.2, and Margaret Livingston (Nokia), Vice Chair of T1P1.2, presented the report from this meeting, T1P1/2001-100.

Mr. Zelmer requested approval of the following actions from the T1P1 plenary:

- Approval of a liaison to Ray Hapeman, Chair of Committee T1, with regards to the ITU-R WP8F letter of conveyance. This document can be found in T1P1/2001-101.
- Approval of the letter of conveyance to ITU-R WP8F. This document can be found in T1P1/2001-102.
- Request a full day meeting with TR46.2 on Wednesday, October 31, 2001, at the next meeting of T1P1.

It was noted that the deadline date mentioned in the liaison (T1P1/2001-101) should read October 3, 2001, and with this change made, the document was renumbered T1P1/2001-101R1. These recommendations were approved by T1P1 as modified.

7 T1P1.3 GSM/3G System and Network Working Group Report

Gary Jones (VoiceStream Wireless), Chair of T1P1.3, and Sonia Garapaty (Nortel Networks), Vice Chair of T1P1.3, presented the report from this meeting, T1P1/2001-096 (modified to T1P1/2001-096R1 due to editorial changes that occurred in the plenary). The following recommendations were presented for plenary approval:

- Approve a liaison to GSM NA on Number Pooling (T1P1/2001-097 with attachment: T1P1.3/2001-199).
- Approve a liaison to the Chair of T1 on input to ITU-T SSG on Q.REF.1 (T1P1/2001-098 with attachment: T1P1.3/2001-197R1).
- Approve a liaison to the Chair of US Study Group B on input to ITU-T SSG on Priority Services (T1P1/2001-099 with attachment: T1P1.3/2001-137R1 and -138R1), modified to T1P1/2001-099R1 during the plenary.
- With reference to the harmonization of the identifiers work in the Circulation group of ITU-R WP8F, approve recommendations that T1P1 support that: 1) there is no need for harmonization of the various unique equipment identifiers (e.g., IMEI, ESN) and, 2) the industry and not the ITU should manage the unique equipment identifier databases. T1P1.3 requested that the Chair of T1P1 convey this agreement to the Committee T1 delegation to 3GPP. (This position was agreed to in the joint T1P1.2/T1P1.3 meeting, refer to T1P1/2001-106, section3)
- With reference to the April 1, 2002, deadline for RSPC submission to ITU-R WP8F, approve recommendation that T1P1 propose that the 3GPP Organizational Partners request a twoweek extension of this deadline. T1P1.3 requested that the Chair of T1P1 convey this agreement to the T1 delegation to 3GPP. (This agreement was agreed to in the joint T1P1.2/T1P1.3 meeting, refer to T1P1/2001-106, section 3)
- Request T1P1 approve the recommendation to form a new Working Group on Network Interworking (T1P1.1).

The liaison contained in T1P1/2001-098 was modified to be addressed to Nick Andre (NCS) and was updated to T1P1/2001-098R1. It was decided that VoiceStream would be the company to bring this input to SA1.

It was noted that an announcement would need to be added prominently to the notice and agenda for the next meeting of T1P1 referring to the intended approval of the 3GPP specifications addressed in T1P1.3/2001-197R1 as T1 specifications.

The proposed mission and scope of work to be done in the proposed Working Group (T1P1.1) can be found in T1P1.3/2001-193. Mark Younge, Vice Chair, asked if there were any objections to having Ron Ryan appointed as Convenor of this Working Group, and the elections are to be held in conjunction with other T1P1 elections in the second quarter of 2002.

These recommendations were approved by T1P1 with the appropriate modifications to liaison T1P1/2001-098.

Mr. Jones also presented the report of the joint meeting of T1P1.2 and T1P1.3 contained in document T1P1/2001-106. T1P1.3 recommended no actions from the plenary out of this meeting other then the two items mentioned earlier in the fourth and fifth bullets at the top of section 7.

8 <u>Other Business</u>

Mel Woinsky (Tantivy) proposed the formation of a new Working Group (T1P1.4) on Wireless Broadband Portable Internet Access. The actual proposal can be found in T1P1/2001-107. There were concerns expressed about whether this subject was already being covered in IEEE 802.16, and whether this scope of work was applicable within T1P1. Concerns were also expressed regarding the meaning of the wording presented in the mission and scope statement, particularly with regards to the use of the term "broadband." A motion was made by Gary Jones (VoiceStream) to "Create T1P1.4 tasked with coming up with an accurate mission and scope for the next meeting of T1P1." This motion was seconded. A vote was held with the results being 8 for the motion, 10 against the motion, and 7 abstentions. The motion was defeated.

A new motion was made by Brian Kiernan (InterDigital Communications) to create an Ad-Hoc Group (AHG) tasked to bring forth:

- The anticipated value-added work from this proposed Working Group
- Resource commitment to such work in T1P1
- Service provider interest in this work
- A revised mission and scope
- Recommendation for establishing a working group per a proposed mission and scope

This motion was seconded. Bob Hall (SBC) proposed a revision, adding to the motion authorization for the AHG to begin work immediately. Mr. Kiernan agreed with this revision, and it was seconded as modified. A vote was held with the results being 12 for the motion, 1 against the motion, and 12 abstentions. This motion carried, and the AHG was formed with Mel Woinsky appointed as the Chair.

- Quent Cassen (Conexant) presented an e-mail from Ray Hapeman, found in document T1P1/2001-104, regarding MEDIACOM 2004. He invited the members of T1P1 to look over this document and forward any appropriate information to the T1P1 leadership.
- Mr. Cassen also requested that all members forward to him the names of any government participants of T1P1 so he can follow up on a request from Ray Hapeman, Committee T1 Chair.

9 <u>Next T1P1 Meeting</u>

The next T1P1 meeting will be hosted by Committee T1/ATIS and will be held October 29-November 2, 2001, in Aspen, Colorado. All the meeting details can be found posted to the T1 web site in T1P1/2001-090.

The T1P1 Leadership meeting, open to all, will be held Monday evening, October 29, 2001, beginning at 5:30 p.m.

T1P1.SAH Report

July 16, 2001 Meeting Ottawa, Canada

The T1P1.SAH group convened at 01:45 p.m. on Monday, July 16, 2001 to progress the work on Lawful Intercept (LI) for GPRS and UMTS systems. Attendance was taken, contributions were ordered, and the agenda was approved.

Liaisons and Reports

The following reports and liaisons were presented for information purposes:

T1P1/2000-077	Report on June 3GPP SA3-LI Meeting
T1P1/2001-083	3GPP SA3-LI Liaison to T1P1
T1P1/2001-084	3GPP SA3-LI Liaison to ETSI

No recommendations or actions were developed from these reports and liaisons.

New Business

a. Contribution T1P1/2001-081 3GPP TS 33.108 LI Handover Interface for Packet Data (Release 99) was presented for information purposes. The contribution contained the latest draft of 3GPP 33.108 which details the HI2 and HI3 interfaces for the GPRS/Release 99 Packet Domain. No recommendations or actions were developed from the contribution.

b. Contribution T1P1/2001-087 LI for GPRS and UMTS was presented for discussion. The contribution outlined a method on how to proceed in developing LI standards for GPRS and UMTS. Consensus was reached to continue the work in T1P1.SAH on LI for GPRS and UMTS and to hold meetings to progress the work on 3GPP 33.108 and an associated T1P1 LI Working Document on GPRS and UMTS (see **Recommendations**).

c. Contribution T1P1/2001-093 Committee Correspondence from TR45.2 to T1 with cc to T1P1 on LAES was presented for discussion. The correspondence discussed the formation of a new TR45 LAES group. Consensus was reached to participate in the new TR45 LAES group when it is formed. It was noted that the scope and work items for the new TR45 LAES group had not yet been developed, but the thoughts expressed were to produce high level, stage 1 material. Accordingly, no agreements were reached on what would be contributed from T1P1. (see **Recommendations** below and **b.** Contribution T1P1/2001-087 above).

The meeting was adjourned at 4:00 p.m. on July 16, 2001 with the following recommendations:

Recommendations

- 1. Continue the process of contributing U.S. requirements into 3GPP 33.108 and adopt the working document in T1P1/2001-087 as a basis for specifying U.S. specific requirements as necessary. If 33.108 fully meets U.S. requirements and there are no U.S. specific requirements, the working document can be discarded.
- 2. Request a meeting in early August and another meeting in September to progress work on GPRS and UMTS LI standards. The results of these T1P1.SAH meetings would be used to contribute as necessary to 33.108 for the 3GPP SA3-LI meetings in August and October.
- 3. Continue to participate in the proposed TR45 LAES activity and provide input to a J-STD-025 revision on packet data as necessary.
- 4. Send a liaison/correspondence to Ray Hapeman in regards to T1P1/2000-093 detailing T1P1's plan for addressing LI standard for GPRS and UMTS (see T1P1/2001-094).

- 5. T1P1 to retain the scope and work item for GPRS and UMTS LI standards including the HI2 and HI3 Handover interfaces as they apply to the U.S./CALEA.
- 6. Request a 1/2 day session for T1P1.SAH in October on Thursday afternoon.

T1P1.3 GSM/3G System and Network Working Group Meeting Summary 07/20/01 – Ottawa, Canada

- 1. **Attendees:** Approximately 30
- 2. **Meeting Schedule:** The T1P1.3 GSM/3G System and Network Working Group met for 3 1/2 days. Gary Jones of VoiceStream chaired the meeting. Sonia Garapaty of Nortel Networks is the vice chair. The agenda and attendance sheets are attached as Annexes 1 and 2.
- 3. **Contributions:** The SWG addressed 68 contributions. The meeting was held electronically, with all of the contributions available in electronic format. The document log is attached as Annex 3.
- 4. **Working Method:** The working group's activities were conducted in plenary sessions with on ad hoc created.
- 5. **Working Group Activities:** The group addressed all the input documents with the following results:
 - 5.1. The agenda in T1P1.3/2001 139R1 was reviewed and accepted. T1P1.3/2001 139R2 contains the modified agenda with a list of contributions corresponding with the agenda items.

It was noted that T1P1.3 met jointly with T1P1.2 on Tuesday morning to address issues of mutual interest. The agenda for this joint meeting is in T1P1.3/2001 – 140R1. T1P1.3 agreed to create an ad hoc to discuss Interworking issues. Since Ron Ryan is the chair of the TR46.2 group, he was asked to convene the ad hoc. The ad hoc met on Monday afternoon.

5.2. IPR Question – Other than reaffirming their company's previously stated positions, does anyone wish to make any statement regarding IPR on standards being worked in this committee?

5.4. Old Business

5.4.1. TTY (167)

Revised 3GPP Release 5 Work Item Description for GTT (a.k.a TTY in the U.S.) was approved at TSG SA #12 (167). It was noted that work on GTT has made considerable progress with the 3GPP Working Groups. Only outstanding work is to complete standardization of the AT commands.

GTT (TTY) is included in the Release 5 version of the 3GPP specifications. However, T1P1 is planning to ballot as an American National Standard only the Release 99 and Release 4 versions of the 3GPP specifications. It was agreed to investigate how the Release 5 GTT specifications can be included in the document(s) to be balloted. The chairman requested that handset manufacturers commit to incorporating CTM in their handsets by the timeframe required and make their progress known to the FCC. Information on the upcoming July 24th TTSI meeting was provided for information (194).

5.4.2. Priority Services (137, 138)

At the last T1P1 meeting, a liaison was sent to GSM NA asking if any standards work related to Priority Access Service (PAS) was needed. The Chair gave an update of the status of PAS within GSM NA, saying that equipment deployed in networks today does comply with GSM 02.11. Currently status:

- Operators are performing an evaluation to check in their network if there is an even distribution of SIMs across all the priority classes.
- GSM NA approved an ad hoc to begin work on the implementation guide and the network requirements.

Two contributions were presented from the National Communications System (NCS). The first was the Functional Requirements for Priority Services from National Communication System (NCS) (137), which provides the functional requirements for the initiatives being taken to fulfill the requirements of the International Emergency Preference Scheme (IEPS) described in ITU-T Recommendation E.106 and the International Emergency Multimedia Service (IEMS) described in ITU-T Draft Recommendation F.706.

The second contribution was the Framework for Supporting Priority Services from NCS (138), which provides further background and a technical framework for IEPS/IEMS in the evolution from today's Public Switched Telephone Network (PSTN), Integrated Services Digital Network (ISDN), and Public Land Mobile Network (PLMN) services to third generation (3G) and next generation networks (NGNs) based upon packet switching technology.

These two documents form the basis of end-to-end priority service, more specifically PAS was only part of the picture; these documents provide the whole picture. NCS have presented these documents to several of the ITU study groups (2, 4, 11, 13, and 16), T1S1, IETF and ETSI. At the time of presentation to SG11, they requested that the U.S. also submit the functional requirements and framework for IEPS service to the ITU Special Study Group (SSG) on "IMT-2000 and Beyond".

NCS requested T1P1 review and approve the documents and then transmit them to the Aug-Sept SSG meeting. Some companies did not feel comfortable about this, because if T1P1 "approves" documents, this would mean that T1P1 endorses what is in the documents. However, it was agreed that T1P1 should not appear as if they are not involved. Therefore, it was agreed that T1P1 submit the documents as a contribution to the SSG, where we will state that these documents have been reviewed. A liaison to Ray Hapeman was developed, asking T1 send a liaison to ITU-T SSG with the two documents attached (204). During review of the liaison, it was clarified that T1 cannot send technical contributions directly to the SSG, it must go through the US Study Group B. Therefore, it was agreed to revise the liaison (204r1) to send it to US Study Group B.

T1P1 is invited to approve this liaison $- \frac{T1P1/2001 - 099}{T1P1/2001 - 099}$.

During the discussion, some felt that SSG might not the first place to contribute the documents, but should also be sent to the groups where the technical work should be done, i.e. 3GPP, and then they would contribute to the SSG and WP8F. It was therefore agreed to send the documents to 3GPP SA1 as these are Stage 1 type of documents and ask that they perform a feasibility study. A 3GPP member company from T1P1 should carry the documents to 3GPP SA1.

5.4.3. PCS1900 Standards Update (151, 152, 153, 154, 155, 156)

The group reviewed two draft T1 standards:

- Draft T1 Standard for 3G Spec R99 & amp; R4 (151)
- Draft T1 Standard for GSM Spec R99 & amp; R4 (152)

The lists contained in the above 2 Draft T1 Standard input documents needed to be updated to include the latest lists of the 3GPP technical specifications/reports (TSs/TRs), which are contained in the following documents:

- CR to 21.101 (153) UMTS Release 99 specifications
- CR to 21.102 (154) UMTS Release 4 specifications
- CR to 01.01 (155) GSM Release 99 specifications
- CR to 41.102 (156) GSM Release 4 specifications

The Draft T1 Standards input documents have a column for Versions. The 3GPP MCC suggested we take this column out as the versions of the 3GPP specifications change at each 3GPP plenary. It was agreed not to include in our T1 standards documents those 3GPP TSs/TRs, which have been identified as not for publication. Also, it was suggested to remove the TRs from the normative list and put them in an informative list.

Note that this is one of three different initiatives that T1P1 needs to do:

- List of 3GPP specifications to ballot as an American National Standard snapshot from TSG #12 for Release 99 and Release 4 of both GSM and UMTS.
- List of 3GPP specifications for input to ITU-T SSG (using the input from the 3GPP CN ITU-T Coordination ad hoc) snapshot from TSG #11 Release 99.
- List of 3GPP specifications for input to ITU-R for RSPC snapshot from March 2002 TSG meeting Release 4 and Release 5.

This was discussed further at the T1P1.2/T1P1.3 joint meeting and it was decided that a small drafting group would convene Thursday afternoon to revise the two documents and submit them to the T1P1 plenary on Friday. In subsequent discussions, it was agreed that the need for balloting of the documents as American National Standards would be postponed.

Proposals to be made to T1P1 regarding revisions to existing T1 standards:

- The first priority is to transpose the core network specifications for the ITU-T SSG input.
- Delay consideration of the ANS ballot as the structure, which we have proposed, is not in compliance with the ANSI rules, i.e. to ballot specific versions of the 3GPP specifications.
- The T1P1.3 Chair, T1P1.2 Chair, Ed Ehrlich, Margaret Livingston and Rob Winstanley volunteered to talk to ANSI about doing away with need for version numbers.
- Try to get the ITU-T and ITU-R to do something about the inconsistency of versions.
- Consider an update of T1.713 in the next 1 or 2 meetings.
- Consider an update of T1.715 beginning of next year when Release 5 is stable.
- Companies should look at the two draft T1 standards (151, 152) for the next T1P1 meeting. What should be the title of these standards?

Refer to the joint meeting report for additional details.

5.4.4. TR45.2 AHES (187, 188, 198)

Discussed at the T1P1.2/T1P1.3 joint meeting. Refer to joint meeting report for details.

5.4.5. Location Services (186)

Discussed at the T1P1.2/T1P1.3 joint meeting. Refer to joint meeting report for details.

5.5. Reports and Liaisons from External Groups

5.5.1. ITU-R WP8F (141, 142, 143, 144, 145, 146, 147, 148, 149, 150)

All ITU-R WP8F documents were presented and discussed at the T1P1.2/T1P1.3 joint meeting with the following actions for T1P1.3:

- Regarding the harmonization of the identifiers work in the Circulation group, it was agreed that T1P1 support the view that
 - There is no need for harmonization of the various unique equipment identifiers (e.g., IMEI, MSN)
 - The industry and not the ITU should manage the unique equipment identifier databases.

T1P1.3 requests T1P1 approve this position and convey this agreement to the T1 delegation.

• Agreed to propose the 3GPP Organizational Partners request a 2-week extension from the April 1, 2002 deadlines for the RSPC submission to the ITU-R Working Party 8F.

T1P1.3 requests T1P1 approve the position and convey this agreement to the T1 delegation.

Refer to the joint meeting report for additional details.

5.5.2. ITU-T SSG (158, 196, 197)

Discussed at the joint T1P1.2/T1P1.3 meeting. Refer to joint meeting report for details.

The group reviewed a liaison from TSG CN to all 3GPP SDO partners giving instructions on contributions requested from the SDOs to the ITU-T Special Study Group on IMT-2000 and Beyond (SSG). The output would be the transposed versions of the 3GPP specifications that are core network related. At the joint .2 and .3 meeting, the ITU-T SSG chairman, who was attending, requested that T1P1 provide input by their August 30th meeting. However, due to the T1 rules, which require at least one-month notice for a ballot to transpose 3GPP specifications into T1 Specifications, it was not possible to ballot the 3GPP specifications in this meeting.

Therefore, it was agreed to draft a document (197) for submission to the ITU-T SSG, based on the CN ITU-T Co-ordination ad hoc document (196), with at least the "Document No." and "Version" columns filled out. A note was added to the document stating that the 3GPP Specifications are planned for approval as T1 specifications at the October T1P1 meeting. Also, at that meeting, the "Status", "Issued Date" and "Location" columns will be filled out.

The document was further revised (197r1) and approved to be forwarded to the T1P1 plenary, along with a draft liaison (202R1) to the chairman of T1, asking that this correspondence be forwarded to the chairman of the SSG and copied to US Study Group B.

T1P1 is invited to approve this liaison $- \frac{T1P1/2001 - 098}{2}$.

5.5.3. Response letter from 3GPP to 3GPP2 on Joint Meeting Proposal (157) provided for information.

The group reviewed a liaison from 3GPP RAN, which answers 3GPP2 TSG C on their request for a joint meeting on the High Data Rate transmission Harmonization. They welcome 3GPP2's effort to organize a meeting to discuss the harmonization of the high speed data rate possibilities for the different techniques belonging to the IMT 2000 technology as described in the ITU-R RSPC. Due to time pressure to complete other tasks required by ITU-R WP8F, 3GPP proposed such a meeting later this year in between the two ITU-R WP8F June and October meetings.

5.5.4. The 3GPP TSG RAN status report to the SA#12 plenary (162) provided for information.

5.5.5. 3GPP TSG CN (159, 160)

Stephen Hayes, TSG CN Chairman, presented the 3GPP TSG CN status report to SA#12 plenary. The PowerPoint presentation is in 159 and the draft status report is in 160, which were provided for information.

5.5.6. 3GPP TSG T (161)

Ed Ehrlich, TSG T Vice Chairman, presented the 3GPP TSG T status report to SA#12 plenary (161), which was provided for information.

5.5.7. The 3GPP TSG GERAN status report (163) and presentation (164) to the SA#12 plenary provided for information.

5.5.8. 3GPP TSG SA (184, 165, 166, 168, 169, 170, 171, 172, 173, 174, 175, 176, 177, 178, 179, 201)

Gary Jones, TSG SA Vice Chairman, presented the 3GPP TSG SA#12 draft report (184). The following are highlights of interest to T1P1 from the report:

- Concern was raised about the incompatibility of mobile stations with the PBCCH service.
- SA1 has completed its investigation on the feasibility of the introduction of 3-digit MNCs. SA WG1 sent a Liaison pointing out the difficulties of this.
- SA1 created an ad hoc to solve the problems of defining User Profile. Their first meeting took place in June 2001. The report (201) from that meeting was provided for information.
- TSs 23.207 "End-to-End QoS Concept and Architecture" and 23.226 CTM Stage 2 were approved and placed under TSG SA change control as version 5.0.0 (Rel-5).
- LCS in Release 5 Work Item Description was postponed due to errors in the description and no supporting companies.
- SA3 clarified the SIM-USIM authentication scenarios. A R99+ SIM talks to a 2G AuC and a USIM talks to 3G AuC, regardless of whether a subscriber is in a R99+ 2G network or a 3G Network. No crossover is possible.
- TS 33.200 "3G Security; Network Domain Security; MAP application layer security (Release 4)" was approved and placed under TSG SA change control as version 4.0.0 (Rel-4).
- Work Item Description proposal from SA4 on Extended Transparent End-to-End Packet Switched Streaming Service (PSS-E) was approved.
- Work Item Description from SA5 to begin a Feasibility study on User Equipment (UE) Management was approved.

• Agenda and scope for the 18 - 19 October 2001 "3GPP Future Evolution Workshop" in Helsinki, Finland was agreed. The workshop is intended to concentrate on such standardisation topics that could be completed within 2-4 years.

5.6. Other Business

5.6.1. SBC presented a contribution on Number Pooling requirements (199). The contribution provides information on a solution for number pooling, which is being worked on in TIA TR45.2. While the solution does not apply to PCS1900, it is offered to T1P1.3 for consideration on any needed work. Wireless carriers must support Number Pooling when Number Portability is supported and required by a State Administration. The FCC date for wireless carriers to support Number Portability is Nov. 27, 2002.

Since number pooling is a U.S. only requirement, T1P1 needs to determine if any changes are needed to the specifications to support this requirement.

The group agreed to draft a liaison to GSM NA Numbering Sub-working group (200) with the SBC contribution attached, asking if any changes are needed to the specifications to

support the U.S. requirement for Number Pooling. If so, then they should communicate these requirements directly to 3GPP SA1, CN4, and T1P1.

The liaison was revised (200) and T1P1 is invited to approve this liaison - $\underline{T1P1/2001 - 097}$.

- 5.6.2. The group reviewed a response liaison from GSM NA Terminal Working Groups on Global Circulation of IMT-2000 Terminals (192). T1P1 sent a liaison at the last meeting asking GSM NA if they were using the global terminal specifications or specifications unique to North America. GSMNA TWG and the PTCRB stated that they are and will continue to contribute to and/or utilize the 3GPP for all specifications, which are unique to North America.
- 5.6.3. Tantivy Communications provided for information a contribution proposing to form a new T1P1 working group, T1P1.4, on Wireless Broadband Portable Internet Access (WBPIA) (205). The contribution was noted.

5.7. Report from the Interworking Ad Hoc (193)

Chris Wallace presented the Interworking Ad Hoc meeting report (193) on behalf of the convenor, Ron Ryan.

The ad hoc requests for the following recommendations:

- 1. Form a T1P1.x working group at this July meeting, appoint a convenor for the October 2001 meeting, and invite TR46.3 to attend a joint meeting with the new working group in October.
- 2. Hold elections for the T1P1.x working group in January 2002 and continue with joint meetings with TR46.3.
- T1P1.3 approved the above recommendations of the ad hoc.

T1P1.2/T1P1.3 Joint Meeting July 17, 2001 Ottawa CA Meeting Report

1. The agenda in T1P1.3/2001 - 140R1 was reviewed and accepted.

2. Revision of T1.713 and T1.715 (151, 152, 153, 154, 155, 156, 190, 191)

T1 Standards T1.713 (190) and T1.715 (191) were provided for information.

The group reviewed the first drafts for T1 standards of 3G specifications:

- Draft T1 Standard for 3G Spec R99 & amp; R4 (151)
- Draft T1 Standard for GSM Spec R99 & amp; R4 (152)

The document has already been discussed at the individual T1P1.2 and T1P1.3 meetings. The individual WGs reached the following conclusions:

- Structure needs to be updated to use the T1 ANS structure.
- Update the lists in the documents with the updated lists in documents 153 156.
- Remove the version column from the lists.
- Agreed not to include the documents that are marked as "no" for publication.
- Agreed to include the list of TRs at the end of the document in an informative section.

The complete list of all the specifications under 3GPP (174) was provided for information. The document indicates which releases the specifications apply to and whether they are still in existence or not.

The group discussed the following options:

- Recommend an update/revision to T1.713 based on the information in these two new documents.
- Recommend these documents as a replacement of T1.713.
- Keep T1.713 and create these two new standards.

The group agreed the last option. A small drafting group will meet on Thursday after the T1P1.2, T1P1.3 closing plenaries to make the updates to the documents.

When T1.713 is up for reaffirmation, then at that time T1P1 can decide, based on the stability of Release 5, if it should be reaffirmed or not.

3. ITU-R WP 8F(141, 142, 143, 144, 145, 146, 147, 148, 149, 150)

- Ed Ehrlich, U.S. representative, reported on the Circulation group (141).
 - For T1P1.2 and TR46.2 to review the unwanted emission documents.
 - Regarding the harmonization of the identifiers, T1P1 should support the view that this should be done by the industry and not have harmonization of IMEI and ESN. This was **agreed and will be conveyed to the T1 delegation at the T1P1 plenary**.
- Report of the WP8F Vision group (142). Major work within this group is to continue work on the Vision PDNR. It was noted that a single Vision document for both the ITU-T and ITU-R would be difficult, but a single vision between the sectors is important.
- Report of the WP8F RTECH group (143). Of interest to T1P1 are the updates to M.1457 (we know it as RSPC): Cdma2000 IXEV/DO (data only) part added.

T1P1 needs to complete its transposition and submit the relevant reference links to ITU-R BR before the April 1, 2002 deadline. The problem is that the 3GPP plenary is 2nd week of March and it will take the MCC a week to update the specifications. This means that T1P1 won't get the list from 3GPP until the 3rd week of March at the earliest. T1P1 will need to have an interim plenary the end of March to approve the document before submission. This does not allow much time to prepare the document for submission.

Given the tight schedule, T1P1 agreed to request ITU-R for a two-week extension allowing us more time to prepare the document. **Convey to the T1 delegation at the T1P1 plenary.**

T1P1.3/2001 -203

The other SDOs may also have the same problem. It was suggested that Asok Chatterjee inform the other members of the PCG via e-mail.

- Report of the Spectrum group (144). This is the largest group. T1P1.2 needs to look at a few documents in the zipped package.
- Working Document towards a PDNR on Adaptive Antennas in WP8F (145). For T1P1.2 and TR46.2 to review. If any problems, then they should be raised at U.S. WP8F.
- Gil LaVean, U.S. representative, reported on the Development group (146). Handbook is progressing very slowly. There was only one contribution, from T1P1. It was noted that Handbook material does not need to go through the T1 delegation. It can go directly to Fabio Leite, as the IMT-2000 Project Coordinator.
- Report of the WP8F ITU-T ad hoc group (147). The group sent four response liaisons to the ITU-T SSG.
- Working Document on a possible new PDNR on Vision and Objectives of the ongoing enhancement of IMT-2000 and of systems beyond IMT-2000 is being developed (148). Very large document! !
- The report of the Work plan group (149) and the Work plan itself (150) were provided for information.

4. ITU-T SSG

(147, 158, 180, 181, 182, 183, 196)

- Several relevant 3GPP ITU-T ad hoc documents (e.g. Report, liaisons, etc) were provided for information (158).
- Contained within 158 and within "SDO input to SSG" is a document on the coordination of SDO input to IUT-T SSG Q.REF-1 from the CN ITU-T Co-ordination ad hoc (SP-010351).

This document was revised during the 3GPP SA plenary (196). 3GPP wants to make sure that all the partners put forward the same set of specifications to the ITU-T SSG. The question was raised to John Visser, ITU-T SSG Chairman and in attendance, on whether this meets the needs of ITU-T SSG. For example, is the addition of a warning on different versions helpful. He replied that it was.

The SSG chairman said they would like to have T1P1's input by their meeting on August 30th meeting. This means that T1P1 needs to perform the transposition of the 3GPP specifications from TSG #11 (following the guidelines in the document from the CN ITU-T Co-ordination ad hoc) into T1 deliverables at this meeting.

This was discussed further in the T1P1.3 meeting.

• The group reviewed the original letter from OHG to SSG (180) and the response to that letter from the SSG (182). As a result of this response, the OHG sent a letter to 3GPP and 3GPP2 (181), also reviewed.

During the discussion, the chairman of the SSG stated they did not reach a unanimous decision regarding the harmonization effort for IP networks. They determined that harmonization is not a high priority activity because there did not appear to be a critical mass of operators supporting the harmonization effort. The OHG said that they will be willing to assist the ITU in hosting a meeting between the two PPs, (3GPP & 3GPP2), which could be organized on the same principle as the workshops organized to resolve the "hooks and extensions". Further discussions are necessary on this topic between the partnerships.

5. Other Issues

5.1. GTT (TTY)

167

Previously discussed at the T1P1.3 meeting.

Approved at the 3GPP SA plenary. Work has progressed quite well, because TTY is Release 5 specifications, but T1P1 needs these documents now in North America was raised. Equipment manufacturers are encouraged to implement the new standards to be available by the June 30, 2002 mandated deadline. Provided for information.

5.2. Priority Access Services 137, 138

Previously discussed at the T1P1.3 meeting.

These are new documents that reflect the full system requirements for Priority Access from an end to end basis. It requires changes to specifications, and these documents will be provided to the SSG, and 3GPP S1, TR45 groups. Provided for information.

5.3. TR45.2 AHES **187, 188, 198**

Margaret Livingston presented the TR45.2 AHES ad hoc meeting report July 12, 2001 (187). TR45.2 approved the recommendation of changing the scope of the project to reflect the current work will be input to J-036 as a revision rather than an addendum. A liaison was sent to T1 to reflect this decision (198). The work plan was updated, Validation and Verification will be initiated by the August 12th, 2001 meeting.

The latest version of PN-3890 addendum 2 version 5 (188) was provided for information.

5.4. Location Services 186

Margaret Livingston presented a Proposed Scope of the work on the LCS Test Cases from GERAN WG4 (186). WG4 has begun work on MS test cases for LCS Release 98/99 and Release 4. This document provided a proposed scope for LCS test cases. The categories were agreed in WG4, and the document was noted. Provided for information to T1P1.
